

We, Youth With a Mission Denver, YWAM Denver take privacy, and transparency very seriously. By using ywamdenver.org, or any of the affiliated links, or by calling us, the user consents to having their data collected. Personal information such as name, gender, birthday, phone number, postal address, email, personal interests, etc.

Student is defined by any person who has begun, completed or attended a school or seminar at Youth With A Mission Denver.

School is defined by a 11-20 week Christian training program on our campus in Arvada, Colorado or Golden Gate Canyon, Colorado (Eagle Rock).

We use third-party service providers for:

These services may access our data solely for the purpose of performing specific tasks on our behalf. We do not share any personally identifying information with them without your explicit consent. We do not give them permission to disclose or use any of our data for any other purpose.

We may, from time to time, allow limited access to our data by external consultants and agencies for the purpose of analysis and service improvement. This access is only permitted for as long as necessary to perform a specific function. We only work with external agencies whose privacy policies align with ours.

We will refuse government and law enforcement requests for data if we believe a request is too broad or unrelated to its stated purpose. However, we may cooperate if we believe the requested information is necessary and appropriate to comply with legal process, to protect our own rights and property, to protect the safety of the public and any person, to prevent a crime, or to prevent what we reasonably believe to be illegal, legally actionable, or unethical activity.

We do not otherwise share or supply personal information to third parties. We do not sell or rent your personal information to marketers or third parties.

Student applications are run through a CRM system, Salesforce. The data collected via Salesforce will be kept for up to 3 years. We will refuse requests for this data from external sources. Data will be shared within Youth With a Mission International (YWAM) upon request of the student.

Salesforce contains data provided by the student. This data includes name, email address, home address, phone number(s), passport information, personal information about life and background of the student, medical history, and travel information.

We may use your information to:

- Process donations, and learn about your donating preferences
- Communicate with you, by phone, text message, mail, and or email
- Address issues with our website, and organization
- Analyze trends and statistics

While applying for a school, students will sign a release of liability, release to audio/visual rights, and payment agreement.

Payment processing

We are committed to protected your Credit card information provided at the time of donations. We will ensure that funds donated to designated to special projects, and of individuals are given to the respective parties at the discretion of Youth With a Mission Denver.

For funds donated to a special project or a Youth With a Mission staff member: Youth With A Mission Denver is a 501c3 nonprofit organization, federal tax ID # 74, 2587748. No goods or services were received in consideration of this gift. Per IRS guidelines all contributions to Youth With A Mission Denver are income tax deductible and made with the understanding that Youth With A Mission Denver has complete discretion and control over the use of all donated funds.

For funds donated to a pay a student's fees: Once tuition of a student is fulfilled, payments will be applied towards their outreach, if applicable. Payments towards students are not tax-deductible. Any payments toward a missions program tuition are applied directly to the individual's account who will be attending the missions training. Although the training we offer helps to accomplish our non-profit goals, payments must be processed for goods or services rendered and are below fair market value

for a secondary level quality training. Therefore payments are not qualified for a tax-deductible receipt per IRS qualifications regarding contributions that can be deducted (IRS publication 529.)

Credit or Debit card information is store until a removal is made at the request of the card/account owner. The owner of the card/account owner must provide the required information for us to access their account. These may include but may not be limited to; last four of card/account number, expiration date of card in question, full name, and last four of SSN (US) or 4 number PIN.

For US citizens we require you input the last four digits of your Social Security Number. This information is only used to confirm we are speaking with you when making changes to your card/ account information.

For international donors we require you create a four digit security pin. This information is only used to confirm we are speaking with you when making changes to your card/ account information.
